I, the undersigned, agree and acknowledge that:

2. This Mission Trip is planned as a Christian activity. I acknowledge that behavior or activity not in keeping with Christian teaching will not be acceptable. I will not impose my particular beliefs or worship style on our Mission Trip hosts.

Every precaution will be taken for the safety and good health of Mission Trip participants, but in the event of an accident or sickness by whatever cause, I will not hold the Canadian Church of God Ministries, nor its Board of Directors, Officers, Volunteers, Mission Trip Coordinators, Contract Operators or Host Missionary(ies) liable for any damages, losses or injuries caused to my person.
4. In the case of an emergency, I understand that every effort will be made to contact the person identified as my Emergency Contact Person. In the event that this person cannot be reached, I hereby give my permission for treatment by a physician or other health care worker selected by the Mission Trip Coordinator(s).
